

## 1 GENERAL PROVISIONS

1.1 These regulations define the procedure for organizing and holding the International Scientific and Practical Conference dedicated to the 85th anniversary of the secondary vocational education system “Modern educational practices for organizing the process of upbringing and education in the context of a professional educational organization: experience, problems, prospects” (hereinafter referred to as the Conference)

1.2 The conference is held in accordance with the plan of events of the State Autonomous Professional Educational Institution of the Sverdlovsk Region "Ural College of Business, Management and Beauty Technology" (hereinafter referred to as the College), the plan of the Union of Directors of Secondary Vocational Education Organizations of Russia and the Council of Directors of Secondary Vocational Education Institutions of the Sverdlovsk Region

1.3 The conference is held as a part of the International Cultural and Educational Forum "Ekaterinburg - BRICS - Africa: Creating the Future Together"

1.4 Conference languages: Russian, English.

## 2 CONFERENCE PARTICIPANTS

2.1 Conference participants are students, teaching staff, teaching methods specialists, employees of educational services, heads of professional educational organizations and comprehensive educational organizations, as well as all interested persons.

## 3 PURPOSE AND OBJECTIVES OF THE CONFERENCE

3.1 The purpose of the Conference is to identify and summarize the experience of best pedagogical practices in secondary vocational education organizations as a stimulus for the development of the educational system.

3.2 Objectives of the Conference:

- presentation of best pedagogical practices through various transmission mechanisms;
- presentation of the results of project-research activities of students and schoolchildren;
- creation of a system of network interaction, expansion of creative contacts between teachers and students.

## 4 CONFERENCE WORK AREAS

The conference is organized for managers, teaching staff and students in the following areas:

**For managers, teaching methods specialists and teaching staff:**

1. Stages of formation of secondary vocational education.

*Features, main differences of the system, history, challenges and directions of development of the professional education system.*

2. Effective practices of professional organizations in organizing career guidance activities in accordance with age characteristics.

3. Modern approaches to organizing of practical training of students within the framework of the Federal Project "Professionalism".

*Features of the organization of practical training of students in professional educational organizations. Application of educational technologies in the classroom training. The connection between theory and practice in the process of practical training. Experience in the implementation of practical training of students.*

4. Project and research activities as a mechanism for developing students' and teachers' cognitive interests and creative activity.

5. Interactive forms of education: problems, implementation practices.

6. Implementation of mentoring models in college: from work experience.

7. Territory of creative industry: current issues, achievements, innovations.

#### **For students:**

8. Stages of formation of secondary vocational education: history of development of the professional education system.

9. Socially significant project (directions: civic-patriotic, professional, education of healthy lifestyle culture, cultural and mass, physical education and sports).

10. Student self-management: experience, traditions, results of activities, presentation of scenarios and developments, new forms of self-government.

11. Information technologies in the educational process: view from the side of the student

12. Territory of the creative industry: current issues, achievements, innovations.

### 5.4 Conference format:

Conference format – by correspondence (publication of articles in a collection).

**As part of the Conference, a "Presentation Competition" will be held (accompanying video sequence to the article submitted for publication).** The presentation should contain no more than 12 slides, taking into account the title page and the final slide of the publication.

*Presentations that do not meet the requirements for the number of slides for the competition will not be accepted. Presentation evaluation criteria Appendix 4.*

Winners and prize winners of the presentation competition will be awarded diplomas for 1st, 2nd, 3rd place in each nomination.

## 6 CONDITIONS OF PARTICIPATION IN THE CONFERENCE

6.1 To participate in the conference, you must send a package of documents by 01.12.2025 (inclusively) to e-mail: **metodist\_mk21@mail.ru**

The package includes:

1. Application for participation (Appendix 1);
2. An article corresponding to the topic of one of the nominations of this conference, formatted in accordance with the requirements (Appendix 2). The article should be no more than 5 pages long;

- 3. Articles that do not meet the requirements (Appendix 2) or received after the deadline for accepting applications will not be accepted for publication.***

6.2 Participation in the Conference is free of charge. The release of an electronic collection of conference materials is free of charge.

## 7 CONFERENCE RESULTS

7.1 Each participant of the Conference will be given a Participant Certificate. Students and teachers who take 1st, 2nd, 3rd place in the "Presentation Competition" will be awarded diplomas of winners of the scientific and practical conference.

7.2 To evaluate the presentations, the organizing committee will create an expert commission. The expert commission for evaluating the presentations is formed from teachers of the Design and Information Systems and Programming training directions as well as from among the social partners of the College in these areas.

7.3 Based on the results of the Conference, a collection of conference materials will be compiled. A link to the electronic certificates of participants, diplomas of winners and a collection of articles will be sent to the e-mail specified in the application and published on the college website.

## FORMATTING AN ARTICLE SUBMITTED TO THE CONFERENCE

The abstract should not exceed 5 pages.

Font type **Times New Roman**,

font **size 14, spacing – 1.5**,

font color – **black**.

Text alignment – **by page width**.

Margins: **bottom – 2 cm; top – 2 cm; left – 2 cm; right – 2 cm**.

Each paragraph should begin with a paragraph indentation, which is 1.25 cm from the left margin of the text and should be unchanged throughout the text (except for numbered and bulleted lists). The paragraph indentation of footnotes (footnotes) should be equal to the paragraph indentation of the main text. Word hyphenation is not allowed.

Throughout the text, uniform density, contrast and clarity of the image are maintained. Colored drawings and diagrams are allowed. When typing text in a text editor, a ban on "hanging lines" is established, i.e. one (last) line of a paragraph should not be carried over to a new page or one (first) line of a paragraph should not be left on the previous page. Each paragraph should contain a complete thought and consist, as a rule, of 4-5 sentences. Surnames, names of institutions, organizations, firms, names of products and other proper names in the text are given in the original language.

Abbreviations of words and phrases in Russian and foreign European languages are formatted in accordance with State Standardization requirements. Illustrations (pictures, graphs, diagrams, computer printouts, charts, photographs) should be placed immediately after the text where they are mentioned for the first time, or on the next page (as close to the corresponding parts of the text as possible). All illustrations should be referenced in the text. When referring to a reference, the word "figure" and its number must be written, for example, "... in accordance with figure 2", etc.

It is not recommended to include large figures in the text.

Illustrations should be numbered with Arabic numerals, consecutively throughout the text (e.g. Figure 1 – Title, Figure 2 – Title). If there is only one figure, it is designated: Figure 1 – Title.

Tables throughout the work are numbered with Arabic numerals, consecutively, preceded by the word "Table" (Table 1. Title), aligned to the right. The font type for the title and text of the table is Times New Roman, the font size is 12, the line spacing is single.

The text in the table header is centered. In the remaining cells of the table, the text material is aligned to the left edge, and the digital material is centered.



All tables must be referenced in the text, and the word "table" in the text is written in full, for example, "... in accordance with table 2", etc.

Pages are not numbered.

The author's last name, first name, and patronymic are printed in bold, in capital letters, on the left side of the sheet.

Below is the name of the educational organization, city.

Single-spaced heading: the heading is printed in capital letters without hyphenation, bold, centered, do not put a period at the end of the heading.

Next, single-spaced:

Keywords (3-5 keywords).

Abstract (2-3 sentences).

Author/s, title, abstract, keywords - in English and Russian.

A list of references is required.

Automatic numbering in the list of references is NOT used.
